- (i) Application complete in all respect, as per prescribed format given here-in-after and addressed to the Chief Executive Officer, Deolali Cantonment Board, should reach at the Office of the Deolali Cantonment Board, Nashik 422401, Maharashtra by Registered/ Speed Post. Applicant must attach two latest passport size photographs indicated his/her name on back side. Postal delay will not be accepted.
- (ii) The envelope containing the application should be clearly superscribed in BOLD letters with the post applied for as follows:-

- (iii) Persons already employed should sent applications through proper channel.
- (iv) The candidate must be a Citizen of India.
- (v) Qualification acquired by the candidates should be strictly in accordance with the prescribed qualifications and the candidates should not seek claim equivalent of their qualification with that of the prescribed qualification.
- (vi) **Candidates must have 02 years experience in supervising the Sewerage work and Sewerage Treatment Plant (STP) or similar type of work.** The candidates are required to submit an experience certificate in this respect. Candidates who do not submit experience certificate, their applications will be rejected.
